Responsibilities

1. Planning and conduct of the annual Summer Series and 'High Noon' Winter Track and Field competitions;
2. Planning and conduct of the ACT Track and Field Championship;
3. Planning and conduct of the Cross Country and Road Running competition;
4. Planning and conduct of the ACT Cross Country Championships and Road Running Championships;
5. The conduct of any special track and field or cross country competitions approved by the Association;
6. Planning and conduct of race walking competition not held in conjunction with summer interclub competition; Assistance with conduct of Lake Burley Griffin walking carnival (if required).
7. Liaising with the Officials Committee on matters affecting the provision of officials for track and field competitions.
8. Ensuring all technical arrangements for the conduct of Track and Field Championships and any other meetings that may be delegated to it by the Association have been properly carried out;
9. Ensuring competition venues are properly laid out and correctly marked and measured and are in good order;

10. Ensuring that equipment, implements and facilities accord with specifications and standards laid down by the Association;
11. Ensuring that competitions are conducted in accordance with the rules;
12. Making recommendations regarding technical equipment and the acquisition, maintenance and use of grounds and equipment.

Committee Roles

Chair

- Convene and Chair meetings of the Committee
- Ensure that the Committee meets its responsibilities under the AACT By-laws
- Reflect the views of the Board at Committee meetings
- Report to the Board on activities of the Committee
- Coordinate the preparation of a report to be included in the AACT Annual Report

Competition Manager

- Coordinate the AACT Competition Calendar
- Take the lead in organising and conducting athletics competitions held under the auspices of AACT including liaising with the Officials Coordinator to advise of officials requirements for each competition

Club Representatives

- Reflect the views of AACT Clubs to the Competition Committee

Officials Representative

- Reflect the views of AACT Officials to the Competition Committee

Coaches Representative

- Reflect the views of Coaches to the Competition Committee

Athletes Representative

- Reflect the views of AACT registered athletes to the Competition Committee

Race Walking Representative

- Reflect the views of the race walking community to the Competition Committee
- Assist the Competition Manager in organising and conducting ex stadia race walking competitions

Cross Country Representative

- Reflect the views of the cross country community to the Competition Committee
- Assist the Competition Manager in organising and conducting cross country competitions

- Reflect, where needed or requested, the views of the ACT Masters Athletics community to the Competition Committee
